Minutes of the Parish Council Meeting of Kirmington & Croxton Parish Council, held on Wednesday 2nd February, 2022, at 7:30pm at St. Helena's Church, Kirmington.

Present - Cllr T Marsden (Chairperson), Cllr D Wells, Cllr S Vickers, Cllr W Turner, Cllr S Taylor, Cllr A Hannigan, Cllr T Walton & 1 member of the public.

01.02.22 - To note Apologies for Absence and to consider any requests for dispensation

Apologies for absence were received from Cllr R Hannigan and Cllr P Clark.

02.02.22- Declarations of Interest need to be remade and recorded in the minutes even if an interest has been declared in the register

Cllr T Marsden declared an interest on any item regarding highway issues on the C137 as he owns a property accessed by this road.

Cllr D Wells declared a personal interest on any item on the agenda in connection with North Lincolnshire Council as he is a Representative.

Cllr W Turner declared a personal interest on any item on the agenda in connection with St. Helena's Church as he is Church Treasurer.

03.02.22 - Procedural - To continue to devolve powers to the Clerk in conjunction with the Chairperson for a period covering the Covid19 Pandemic should the Parish Council be unable to meet

04.02.22- To consider any applications received for Co-Option onto the Parish Council

The Parish Council considered the application received from J Salmon.

Resolution - Cllr D Wells abstained from considering the above application. All other Councillors present confirmed no objections. Clerk to inform NLC.

Cllr S Vickers has been contacted by a resident who expressed concerns that the Bowls Club is being accessed by children who are playing in and around the grounds. They also reported a dead fox on the grounds, which they believe to have been shot.

Resolution - Cllr S Vickers advised the resident to report to the Police. The Parish Council requested the Parish Clerk report to the Brocklesby Estate.

Cllr S Taylor informed the Parish Council the event on the Village Green for the Queens Jubilee Celebrations will be held on the Sunday 5th June, 2022.

Clerk advised the Parish Council have been awarded the Spring in Bloom Grant. The grant requires claiming and planting by 3rd March. Cllr D Wells has contacted NLC for permission to plant the trees on the roadside. Cllr T Marsden and the Clerk signed the acceptance forms.

Clerk advised the Parish Council have been successful in their grant application for the 2 x new noticeboards, 2 x benches, football roller, football nets. The installation of the noticeboards and benches will be mid to late April. Cllr T Marsden and the Clerk signed the acceptance forms.

07.02.22 - Accounts - To set the budget/precept for 2022/2023

The Parish Council considered the budget/precept information circulated by the Clerk.

Resolution - The Parish Council agreed to set the precept at £11,625 and accept the support grant at £875 from North Lincolnshire Council and confirmed they adhere to the terms and conditions. (Total £12,500) Clerk to inform NLC.
